## Available Information Sources

The following table lists the data provided by Kaiser Partner Privatbank AG. This data feed contains information as of the previous booking day according to the granularity available in the banking system.

- **Exchange rates**  
Contains rates to CHF as per the reference date
- **Asset prices (for securities)**  
Covers the latest prices in the default market
- **Positions**  
Holds positions as of the reference date
- **Transactions**  
Contains all transactions booked at the reference date
- **Transaction details**  
Covers the components of a transaction (e.g. costs or fees)
- **Cash bookings**  
Contains all cash bookings on money accounts booked at the reference date





## Information on Delivered Data

- **How to get EDD**

The EAM and Kaiser Partner Privatbank AG shall initially exchange credentials and IT access information in order to setup the secured line of exchange and allow Kaiser Partner Privatbank AG to provide its EDD service to the EAM.

- **Data delivery**

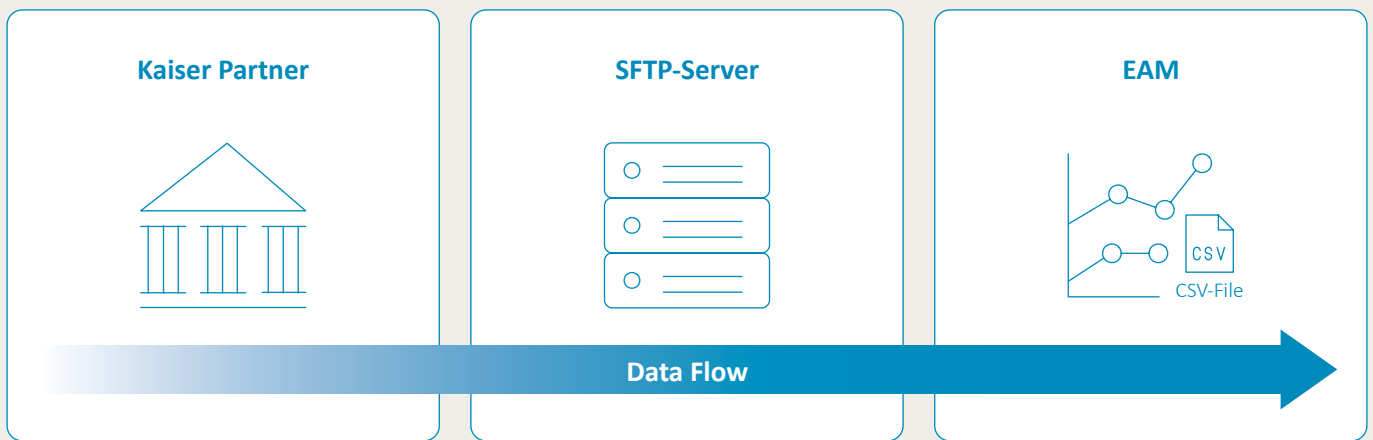
The data is transferred in a CSV file, which is supplied on a dedicated SFTP server by Kaiser Partner Privatbank AG in an electronically readable format. One row is estimated per data set. The file transfer is executed from Monday to Friday, +/- 8:00 UCT, and contains the previous day's business data (reference date).

- **When to use Kaiser Partner Privatbank AG's EDD service**

EDD is mainly intended for EAMs servicing multiple client accounts and extracting and processing banking information in their own portfolio systems. Each delivery consists of data on completed and settled transaction(s), including positions and prices as per the reference date.

- **When to use Kaiser Partner Privatbank AG's e-banking service**

Kaiser Partner Privatbank AG's e-banking service may be applied for intraday processing and banking orders.
