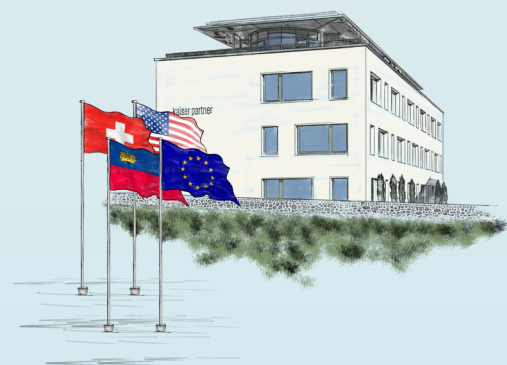

Custodian bank for external asset managers

Kaiser Partner Privatbank AG offers (domestic and international) external asset managers (EAMs) a service that is specifically tailored to the needs of EAMs and joint clients. In particular, it comprises account/custody management and order processing, including (stock) trading.

Custodian bank for investment firms and funds

Management companies of investment firms or funds may appoint Kaiser Partner Privatbank AG as a custodian bank.

External electronic data delivery

Kaiser Partner Privatbank AG has developed an electronic data delivery (EDD) service for the automated transfer of data to our clients' IT systems. The data deliveries contain information on executed transactions. With EDD, users can download an account (SWIFT MT950) or portfolio statement (SWIFT MT571). EDD is mainly intended for EAMs servicing multiple client accounts, and it enables them to extract and process banking information in their own portfolio systems.

Services for Clients of Kaiser Partner Privatbank AG

Securities processing and (stock) trading

This service includes the handling of securities transactions from start to finish, as well as the recording, settlement – in particular the stock and OTC trading of securities orders – and the related reporting.

Payments

Payment transactions include the processing of payments (single payments, standing orders, and debits) from entry to execution up to and including appropriate reporting.

Precious metals management

This service includes the storage and trading (if applicable) of precious metals in physical form (bullions and coins) in separate Kaiser Partner Privatbank AG safe deposits. This way, precious metals may be used as collateral for loans as well.

Safe deposit boxes

Clients may rent specially secured safe deposit boxes in various sizes for the safe storage of their valuables.

E-Banking

Kaiser Partner Privatbank AG's E-Banking service allows the user to manage assets in a targeted way in the digital world. The E-Banking service meets the highest security standards. The benefits include access to key international financial and trading venues, as well as detailed monitoring of asset performance and analysis. It also allows the user to maintain a better overview thanks to ad hoc reports and additional monthly E-Documents.
